The Committee continued to fulfill its responsibilities to advise and educate Members and staff on the laws, rules, and standards of conduct.¹ As a general matter, the Committee's activities in receiving and responding to requests for advice from House Members and staff are conducted on a confidential basis. The Committee received 13 requests for advisory opinions in August of 2016.

In accordance with the Rules of the House of Representatives for the 114th Congress, the Committee continued to review and approve requests to accept privately-sponsored, officially-connected travel. The Committee received 54 such requests in August of 2016.
