Dear Mr. President:

Congratulations on your reelection. I look forward to continuing our work together to address and rectify the issues facing our nation. I commend you for giving one of those issues a national platform in your victory speech: The need to reform of our electoral system.

As ranking Democratic Member and former Chairman of the Committee on House Administration, I have worked diligently, with Members from both sides of the aisle, to nurture and protect one of our most precious rights: the right to vote. Unfortunately, many lawmakers at the state and federal level seem to have dreadfully short memories, as this right is under assault. I share in your commitment to protect the right to vote and I look forward to working with you to achieve our common goal of free and equal access to the ballot.
