SUBJECT: Litigation Status Report

The attached litigation report consists of four parts:

- A list of all court cases opened or closed during the previous month.
- A "Pre-Litigation Report" that lists all cases for which the Commission has authorized civil litigation, but for which no court complaint has yet been filed. The list identifies the names of the primary respondents, MUR numbers, dates on which contingent and/or final suit authority was approved, and the staff assigned to the matter.
- A "Pending Litigation Report" that lists all litigation cases that are open as of the date of this report. This list identifies the name of the court case, the case number assigned by the court, the staff working on the case, the related MUR number (if any), and the applicable litigation budget category.
- A "Litigation Activity Report" that lists all court filings for the previous month. Each case for which there has been court activity is listed on a separate page, and each filing is identified by date and name, with further explanation in italics when appropriate. At the top of the first page for each individual case, the report includes information that does not change each month, such as the case name and number, the judge's name, when and where the case was filed, and a description of the issues in dispute. Because we occasionally learn of court filings several days, or even weeks, after they have been submitted to the court, we will sometimes list activity from an earlier month.

Description:

This is an action brought by Campaign Legal Center and Catherine Hinckley Kelley under 52 U.S.C. § 30109(a)(8), challenging the Commission's dismissal of their administrative complaints in MUR 7146 (Correct the Record/Hillary for America). The administrative complaints alleged that these committees violated FECA by engaging in a multi-million dollar coordination scheme and failing to report coordinated expenditures. The District Court granted Plaintiffs' Motion for Summary Judgment; denied Defendant-Intervenor's Motion for Summary Judgment; and entered judgment in favor of the Plaintiffs. The FEC appealed.

In this case, John Anthony Castro seeks declaratory and injunctive relief pursuant to 52 U.S.C. 30109 for the FEC's alleged failure to act on a purported administrative complaint alleging that the FEC should declare Donald J. Trump a "candidate" for president based on his electoral activities, but also refuse to accept his FEC Form 2 on the grounds that his involvement in the events of January 6, 2021 renders him constitutionality ineligible for that office. Plaintiff alternatively alleges that the FEC's "testing the waters" regulation at 11 C.F.R. 100.72 is invalid under the Administrative Procedure Act.

In this case brought under 52 U.S.C. § 30109(a)(8)(A), End Citizens United challenges the dismissal of its administrative complaints, which alleged that U.S. Senator Rick Scott, Rick Scott for Florida and New Republican PAC violated 52 U.S.C. § 30102(e)(1), 30103(a), 30104, and 30125(e). The administrative complaints allege that in the 2018 Florida Senate race, the candidate and campaign failed to file required statements and reports and that New Republican PAC unlawfully accepted prohibited campaign funds and coordinated expenditures with the campaign resulting in excessive contributions. The district court granted summary judgment to defendant-intervenor New Republican PAC and the plaintiff appealed.
