SUBJECT: Policy Division Quarterly Report for FY 2023 Q3 (4/01/2023 — 6/30/2023)

This report provides the Commission with the status of projects in the Policy Division of the Office of the General Counsel during the third quarter of FY 2023 (4/01/2023 — 6/30/2023). The report assesses the Division's work on advisory opinion requests ("AORs"), rulemaking projects, and compliance advice projects during the quarter. The tables set out in Appendices A, B, and C provide specific data regarding AORs, rulemakings, and compliance advice projects, respectively, for the third quarter of FY 2023. The chart in Appendix D contains information on consultations and reviews conducted by the Division during the third quarter of FY 2023.

The Commission issued two advisory opinions during the third quarter and had two AORs pending at the end of the quarter. The Commission also had 20 active pre-AORs pending during the third quarter. Please see Appendix A.

The Commission had 28 open rulemaking matters in Quarter 3 of FY 2023. Of those, 8 were pending rulemakings initiated by the Commission and 20 were rulemaking matters initiated by one or more petitions for rulemaking. Please see Appendix B.

The Division completed a total of 12 formal compliance advice assignments during the third quarter of FY 2023, completing them within an average of 19 days. Please see Appendix C.

The Division routinely and actively engaged in work on other types of matters. Most notably, the Division provided legal advice and assistance to the Commission in the ongoing Audit process revision project. These other types of matters include, but are not limited to, drafting answers to questions from the Ranking Member of the House Administration Committee, consultations for MURs, RAD reporting, Special Election Notices, Information Division communications, and proposed changes to various Commission procedures. # **ADVISORY OPINIONS**

The Policy Division evaluates its processing of advisory opinion requests ("AORs") based on the following performance measures:

#### **Internal Performance Measures**

- Screen all advisory opinion requests for completeness within 10 days of receipt and obtain additional information as warranted
- Distribute internal and public drafts in a timely manner so that the Commission may issue advisory opinions within the 60-day or 20-day statutory timeframes, or within such other timeframes as may be requested by the Commission

### Performance and Accountability Report and Budget Performance Measures

- Issue advisory opinions within 60-day and 20-day statutory deadlines 100% of the time
- Issue expedited advisory opinions for time-sensitive highly significant requests within 30 days of receiving a complete request, or a shorter time when warranted, 100% of the time

#### Advisory Opinion Work in Quarter 3

The tables that follow provide quantitative data regarding the disposition of advisory opinion requests during the most recent fiscal quarter. Table 1 provides the number and disposition of active AORs. Table 2 shows the average number of days that it took from the receipt of complete AORs to a Commission vote. Table 3 provides data on screening pre-AORs.

The Policy Division evaluates its work on rulemaking projects based on the following performance measures:

### **Internal Performance Measures**

- Draft and circulate NPRMs, Final Rules and Explanations & Justifications (E&Js), and other rulemaking documents within the timeframes determined by the Commission
- Coordinate with the Federal Register, the Internal Revenue Service, Small Business Administration, and the Office of Management and Budget (OIRA) to ensure timely compliance with all applicable statutory, regulatory, and other requirements

### Performance and Accountability Report and Budget Performance Measure

• Complete rulemakings within specific time frames that reflect the importance of the topics addressed, proximity to upcoming elections, and externally established deadlines 100% of the time. External deadlines include those imposed by statute, court opinion, or the Commission.
