STATUS OF OIG AUDIT RECOMMENDATIONS

DISASTER RECOVERY PLAN AND CONTINUITY OF OPERATIONS PLAN AUDIT (Jan. 2013)

On January 30, 2013, an independent auditor issued an inspection report on its inspection of the FEC's Disaster Recovery Plan (DRP) and Continuity of Operations Plan (COOP). The FEC has resolved 28 of the findings issued, and two remain open.

Recommendation 11: Procure the necessary hardware/software to fully test the data entry application needed for Disclosure by December 2013.

Decision: The OCIO conducted a review of the Data Entry application and determined there is no need to purchase systems for testing. Subsequently, the FEC awarded a contract in 2020 to address testing, training, and table top exercises to ensure continual program development through the validation of existing plans, policies, and procedures. The Data Entry application was included in the DRP provided to the FEC by those consultants.

The Data Entry application has since been migrated from a physical data center to a cloud environment. The OCIO's IT Modernization Team is implementing a DRP for the FEC's cloud environment which will include the Data Entry application and expects to complete this by mid FY 2024. The implementation of the DRP will be completed and then submitted to the independent auditors once it is completed. In addition to having completed an incident management test exercise, the OCIO is: finalizing an Information System Contingency Plan (ISCP), performing a yearly system classification review, and working actively with AWS Team to complete the COOP/DRP/ISCP updates.

Recommendation 12: Ensure the disaster recovery Kofax server is updated to mirror the Kofax production server by June 2013.

Decision: The FEC awarded a contract in 2020 to address testing, training, and table top exercises to ensure continual program development through the validation of existing plans, policies, and procedures. The Kofax disaster recovery server was included in the disaster recovery plan provided to the FEC by those consultants. Subsequently, this server has been migrated from a physical data center to a cloud environment. The OCIO's IT Modernization team is implementing a DRP for the FEC's cloud environment which will include the disaster recovery Kofax server application and expects to complete this by mid FY 2024. The DRP will be submitted to the independent auditors once it is completed. In addition to having completed an incident management test exercise, the OCIO is finalizing an Information System Contingency Plan (ISCP), performing a yearly system classification review, and working actively with AWS Team to complete the COOP/DRP/ISCP updates.

ALLEGATIONS OF BIAS AGAINST FEC PERSONNEL REVIEWING 58TH PRESIDENTIAL INAUGURAL COMMITTEE REPORTS INVESTIGATION (Aug. 2021)

In August 2021, the OIG issued a summary of its investigation. According to OIG, “the investigation found that the RAD senior manager and other RAD personnel acted consistent with relevant law and policy concerning review of the Inaugural Committee’s reports.” Five recommendations were issued, and OIG has closed one of them, which leaves the four recommendations described below open.

Recommendation 2: Update Standard 21 to include the criteria for a serious violation and provide measurable standards concerning the review of inaugural committee reports.

Decision: The Commission considered revisions to update Standard 21 to address this recommendation as it considered the 2023-2024 RAD Review and Referral Procedures. The final version approved on February 7, 2023 did not include these updates. The Commission will revisit this issue as it considers subsequent versions of the RAD Review and Referral Procedures.

Recommendation 3: Update the inaugural committee review process to include electronic review and potential quality control reviews.

Decision: RAD has incorporated the quality control review of FEC Form 13 (Report of Donations Accepted for Inaugural Committee) into its quality review program.

Recommendation 4: Memorialize a policy concerning the identification of potential foreign donation and the Commission should consider updating relevant forms and instructions to ensure filers are aware of verification requirements imposed by federal regulation.

Decision: The Commission considered revisions to update Standard 21 to address this recommendation as it considered the 2023-2024 RAD Review and Referral Procedures. The final version approved on February 7, 2023 did not include these updates. The Commission will revisit this issue as it considers subsequent versions of the RAD Review and Referral Procedures.

Recommendation 5: Include specific thresholds that trigger the issuance of RFAs for donations with foreign addresses, notwithstanding purported “verification” by the relevant committees.

Decision: The Commission considered revisions to update Standard 21 to address this recommendation as it considered the 2023-2024 RAD Review and Referral Procedures. The final version approved on February 7, 2023 did not include these updates. The Commission will revisit this issue as it considers subsequent versions of the RAD Review and Referral Procedures.

FEC CONTRACTING OFFICERS REPRESENTATIVE (COR) PROGRAM SPECIAL REVIEW (May 2022)

On May 26, 2022, the OIG transmitted the results of its Special Review of the Contracting Officer's Representative (COR) Program. Two recommendations were issued, and OIG has closed one of them, which leaves the recommendation below open.

Recommendation 1: The Procurement Office should memorialize the COR certification tracking procedures it has implemented.

Decision: The Procurement Office has automated its COR certification tracking procedures, and expiration dates are included in the Aeon Procurement Management system.
